Emergency and First Aid Procedures:

Steps to be Taken in Case Material is Released or Spilled:
ELIMINATE SOURCES OF IGNITION. VENTILATE AREA OF LEAK OR SPILL. WASH AWAY WITH WATER IF PRACTICAL. IF USE OF WATER IS NOT PRACTICAL, ABSORB SPILL WITH EARTH OR VERMICULITE AND REMOVE TO OUTDOORS FOR DISPOSAL. DO NOT USE FLAMMABLE MATERIALS SUCH AS SAWDUST.
