# SECTION 6 HEALTH HAZARD ASSESSMENT

#### General:

Limited toxicity data are available on this specific product; this health hazard assessment is based on the results of screening tests.

#### Ingestion:

The acute oral  ${
m LD}_{50}$  in rat is above 5 g/kg. Relative to other materials, a single dose of this product is practically nontoxic by ingestion. Irritation of the mouth, pharynx, esophagus and stomach may develop following ingestion.

## Eye contact:

This material is severely irritating in rabbit eye studies; a similar degree of irritation will probably occur after human eye contact.

### Skin contact:

This material is nonirritating in rabbit dermal irritation studies; it is not likely to irritate human skin.

## Skin absorption:

This product is not likely to be absorbed through human skin.

### Inhalation:

Although the potential for respiratory sensitization is expected to be low from exposures to dusts generated from this dyestuff, some individuals have developed respiratory allergic reactions after repeated and/or prolonged exposures to high atmospheric concentrations of dust from some reactive dyes, of which Procion dyes ar one type. Cough, tightness in chest, and/or asthmatic wheezing may be signs of respiratory allergy.

First aid procedures (continued):

Eyes: Immediately flush with plenty of water for at least 15 minutes and have eyes

examined and treated by medical personnel.

Steps to be taken in case material is released or spilled:
