The acute oral ${\rm LD}_{50}$ in rat is probably above 5 g/kg. Relative to other materials, a single dose of this product is practically nontoxic by ingestion.

This material is likely to be slightly irritating to human eyes following contact.

Irritation may develop following repeated and/or prolonged contact with human skin.

Inhalation:
