

**Articulation Agreement**  
**between**  
**Syracuse City School District (SCSD)**  
**725 Harrison St, Syracuse, NY**  
**and**  
**Onondaga Community College**  
**4585 West Seneca Turnpike,**  
**Syracuse, NY**

The signatories of this articulation agreement, Syracuse City School District (SCSD) and Onondaga Community College (OCC), declare their intention to participate in a partnership for the purpose of delivering educational instruction to eligible students. The parties to this agreement have reached the following understanding:

**1. Term**

The term of this agreement shall be for five years from July 1, 2024 – June 30, 2029 and subject to the following conditions:

- Both parties have the option to extend this agreement for one (1) additional five-year period giving written notice to each other no later than ninety (90) days prior to the expiration date.
- SCSD and OCC reserve the right to terminate this Agreement with written notice submitted within thirty days of the date of the end of each school year. In this event, the date of termination will be the day after the end of the semester during which the 30-day period expires. If neither party requests to terminate this Agreement prior to the end of the term of this agreement, then the parties may elect to renew the agreement.

**2. Modification and Waiver**

No waiver or modifications shall be valid unless it is in writing and signed by OCC and SCSD.

**3. Curriculum and Courses**

Students who have enrolled in the Electrical Trades program at Syracuse City School District will be eligible to enroll in College Credit Now and earn credit for:

- CIS 100, Information and Computer Literacy, ENG 103 and 104, Composition I and II, and COM 210, Public Speaking, subject to an annual Memorandum of Understanding and the availability of a credentialed high school instructor or the identification of an OCC faculty member to teach the course on- premises at the Public Service Leadership Academy location.
- The above courses offered through the OCC College Credit Now Program are required for the Electromechanical Technology, AAS degree at OCC.
  - o The course alignment is subject to curriculum changes at OCC during the term of this agreement and both parties shall agree to modifications of this agreement should curriculum changes require the course offerings be updated.
  - o Tuition for concurrent enrollment courses will be incurred according to all applicable requirements in place by the State University of New York. For courses taught by Onondaga Community College faculty, the Syracuse City School District will incur additional costs set by annual Memorandum of Understanding between SCSD and OCC.


- Students will be assisted in the course registration process by OCC.

4. **Students**


Each student must enroll, and remit payment as required by SUNY for the course(s) with OCC through the College Credit Now registration process as directed by the Concurrent Enrollment Office.

5. **Entire Agreement**


