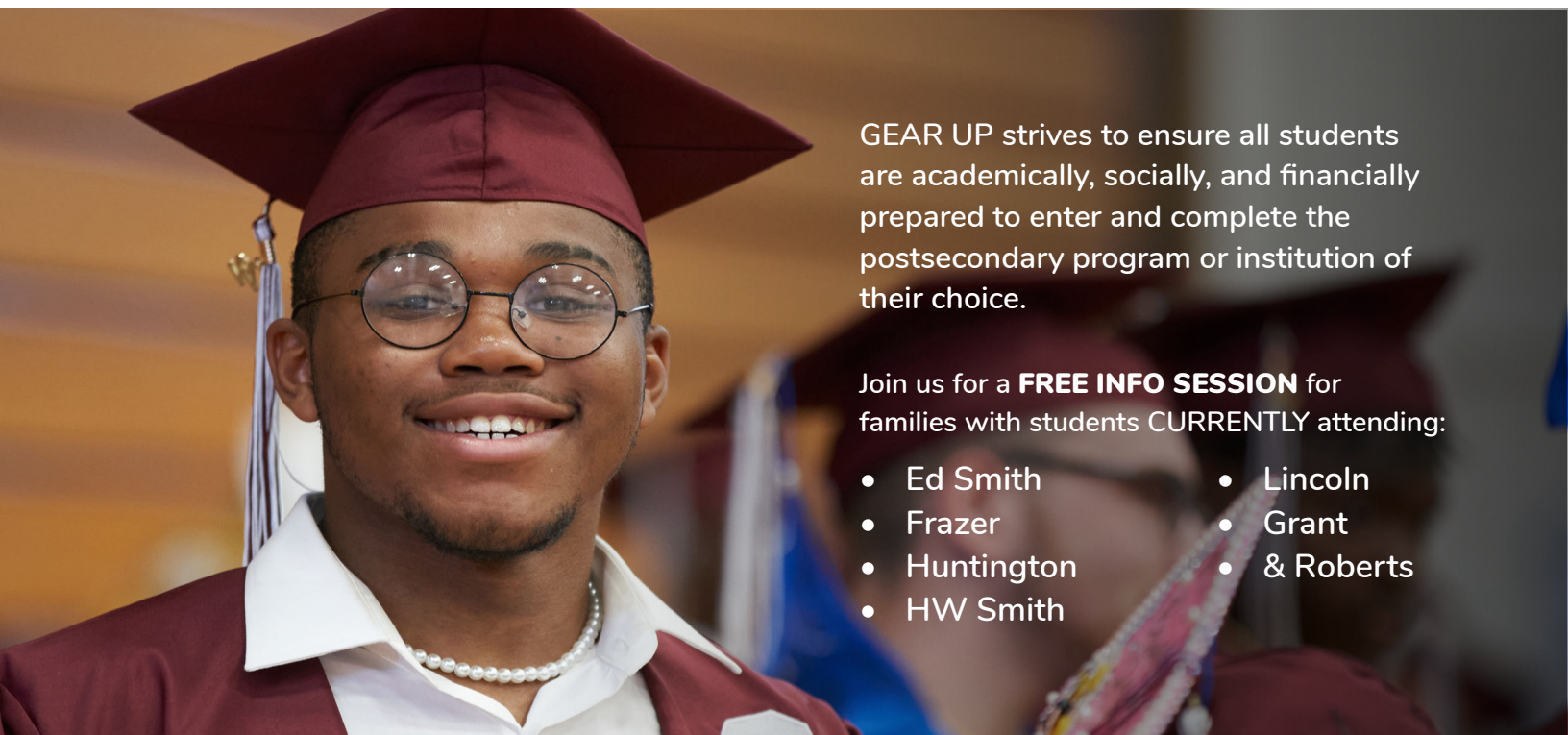

### NOTICE OF NON-DISCRIMINATION
